

SUS Ads 2023 — Microsite Quizzes

TERMS & CONDITIONS

The SUS Ads Microsite Quizzes (the “Quizzes” and each a “Quiz”) are co-organised by REACH, a department of the Ministry of Communications and Information, mm2 Entertainment Pte Ltd and AsiaOne Online Pte Ltd (collectively “the Co-organisers”).

The Co-organisers shall retain full discretion to determine all matters and disputes pertaining to the Quizzes. The Co-organisers may, at their discretion, disqualify any Participant who has failed to comply with any of these Terms and Conditions. The Co-organisers may also at any time require any finalist or winner, who has failed to comply with any of these Terms and Conditions, to forfeit and/or repay any cash or prize that they have received.

Eligibility

1. Every person who participates in either or both of the Quizzes (“the Participant”) must be above the age of 16 as of 31 Dec 2023. Persons below 18 years old as of 31 Dec 2023 will require parental OR legal guardian acknowledgement and consent to participate.
2. The Quizzes are open to all Singapore Citizens and Permanent Residents.
3. Participants must comply fully with the Terms and Conditions set out herein. The Co-organisers reserve the right to disqualify any Participant / entry that does not, in the view of the Co-organisers, comply with any of these Terms and Conditions.
4. Participants shall, if requested by the Co-organisers, present their identification, place of residence and/or evidence of parental / legal guardian consent, for verification.

Microsite Quiz Period

The Quizzes will be available for participation at <https://www.SUSAds2023.sg> from 7 July 2023 to 25 August 2023, and there will be two (2) separate rounds of quizzes.

1. SUS Quiz 1: 7 July 2023 — 31 July 2023
2. SUS Quiz 2: 1 August 2023 — 25 August 2023

While both Quiz 1 and Quiz 2 will be available from 7 July 2023 to 25 August 2023, only entries submitted during the applicable competition period in respect of each Quiz (as specified above) will be eligible to stand a chance to win the Prize for that Quiz.

Participation

1. To stand a chance to win a pair of digital Cathay Cineplexes Movie Vouchers (“the Prize”) in each Quiz, the Participant is required to provide a unique email address.
2. Participation is not limited to only one (1) quiz. Participants can take part in both quizzes.

Prizes

1. There will be fifty (50) winners for each Quiz, and each winner will win a pair of digital Cathay Cineplexes Movie Vouchers (“the Prize”). The winners will be drawn at random by the Co-organisers.
2. If the winner is not found eligible for the Quizzes, the Co-organisers may at their discretion forfeit the Prize or reclaim it after awarding and choose another winner.
3. Co-organisers reserve the right to substitute or replace the prize with any other prize of equal or similar value without prior notice.

1. The Prize will be sent to the winners via the email address which they have provided in their Quiz entry.

4. Winners whose email addresses are invalid would have their eligibility forfeited and an alternate winner may be selected.
